## Hulmeville Borough Request for Party Status

### Instructions

- If you wish to be a Party to the Proceedings, for any Borough hearing, you must complete the attached application and submit it to prior to the first meeting on the subject hearing.
- A separate application must be submitted for each hearing (note, this does not apply to rescheduled or continued hearings once an application has been accepted).
- Application to be a Party to the Proceedings is not automatically accepted. The applicant must explain how they are affected by the proceedings. Determination whether to accept the application solely rests on the committee or council conducting the hearing.
- If approved as a Party to the Proceedings, the applicant is required to attend all hearings on the subject. Failure to attend any hearing may result in revocation of party status.
- Any cost incurred due to actions by the party are solely the responsibility of the Party. If a court considers that you have acted unreasonably you can be ordered to pay the costs incurred by other parties.
- Applications should be mailed or emailed, preferably at least 1 week prior to a scheduled hearing. Applications may also be delivered in person, prior to the start of a hearing. Mail or email completed applications to:
