Motion made by Mr. Mitchell seconded by Mr. Wasson to approve the minutes of December 23, 2024; Motion passed with all in favor 5-0-0.

Water and Sewer Clerk: no report

Water Meter Reader:

- Quarter Meter Reading Ms. Wheeler was able to read the meters and get the bills out. The issues she was having were with Munibilling. Once the issues were resolved everything went smoothly.
- Meter Replacement Program Ms. Wheeler had 12 meters left to replace. The issue now
 is with new meters leaking. There were three meters last month and one meter this
 month that have issues with leaking. Ms. Wheeler remembers that when they originally
 negotiated the deal for the new meters the company promised the Authority that they
 would receive an iPad to assist with the meter readings. Currently Ms. Wheeler is using
 her cell phone. Her cell phone bill is \$40 a month. She believes that the iPad will require

internet, and she does not know how much that will cost the Authority it may be more than just paying her cell phone bill. Mr. Harris will have Bill Wheeler contact Munibilling regarding the promised iPad.

- Water Pressure Mr. Mitchell inquired about the water pressure in the Borough. His property has lost water pressure. Ms. Wheeler suggested checking his pressure reducing valve which can cause that problem if it goes bad.
- Eric Schmid Property Main St Ms. Wheeler wanted to remind the Authority that if the meter in the property owned by Eric Schmid is bad due to the cold weather, he is responsible to purchase the replacement. The basement on the property is open and she does not believe the house has heat. Ms. Wheeler will check with Ms. Slater to see if the property has had any water readings.
